- Pull out charges 300 SAR per container if applicable
- 15 days free of storage at yard/depot
- Storage of containers beyond 15 days will be charged at SAR 38 per container per day.
- 4 hours free truck waiting time for stuffing/destuffing, thereafter SAR 100/hour and up to800 per day (for dry containers)
- Hazardous/Dangerous Cargo surcharge during trucking: USD 100/Container.
- Trucking Charges are for gross container weight of 23.9 tons max, Overweight containersaby 24 tons (tare+cargo) will be charged USD 150 extra up to 29.9 tons.
- Maersk will not be responsible for any cargo handling (stuffing)

All other charges which are not explicitly mentioned above and all third-party charges/outlayswhich are subject to actual cost and against supporting document

## General Terms & Conditions

- Rates are valid only for GENERAL cargo. They are not valid for Hazardous, over dimensional, Perishable cargo, unless otherwise specified.
