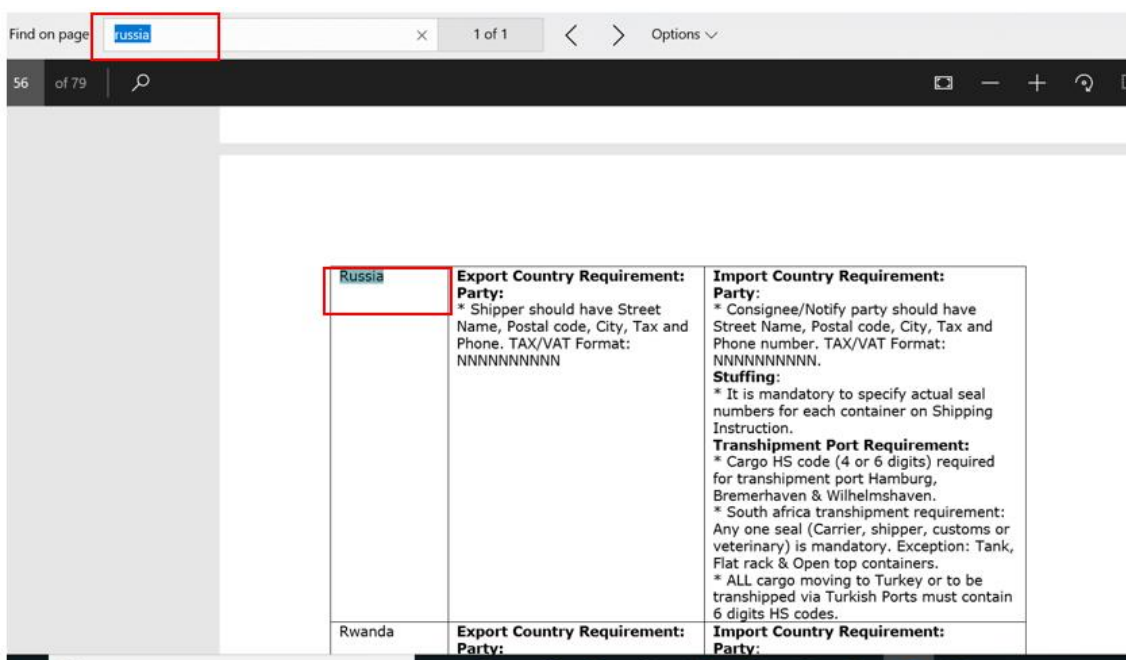
To enjoy hassle free shipping service, we urge our customers to provide the necessary information regarding the Cargo along with the Shipping instruction.

This tool provides comprehensive list of all the legally required information that one should provide while shipping the Cargo based on the country of origin and destination.

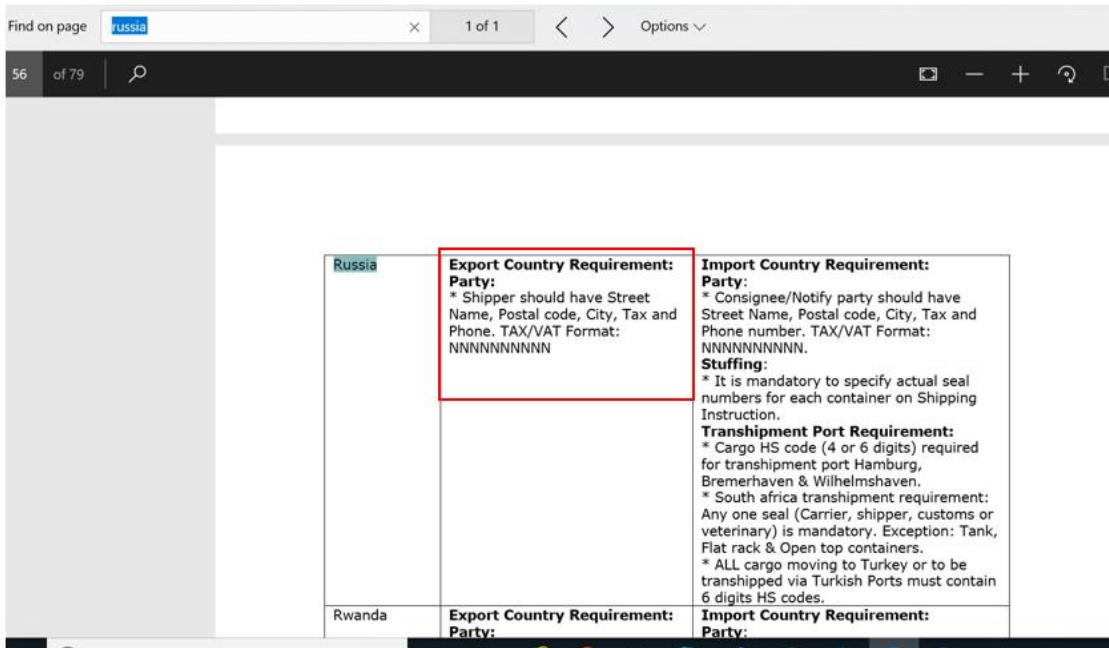

**Step 1-** Do a quick search in the document using **Ctrl+F** to find the Country of Origin Eg- Russia

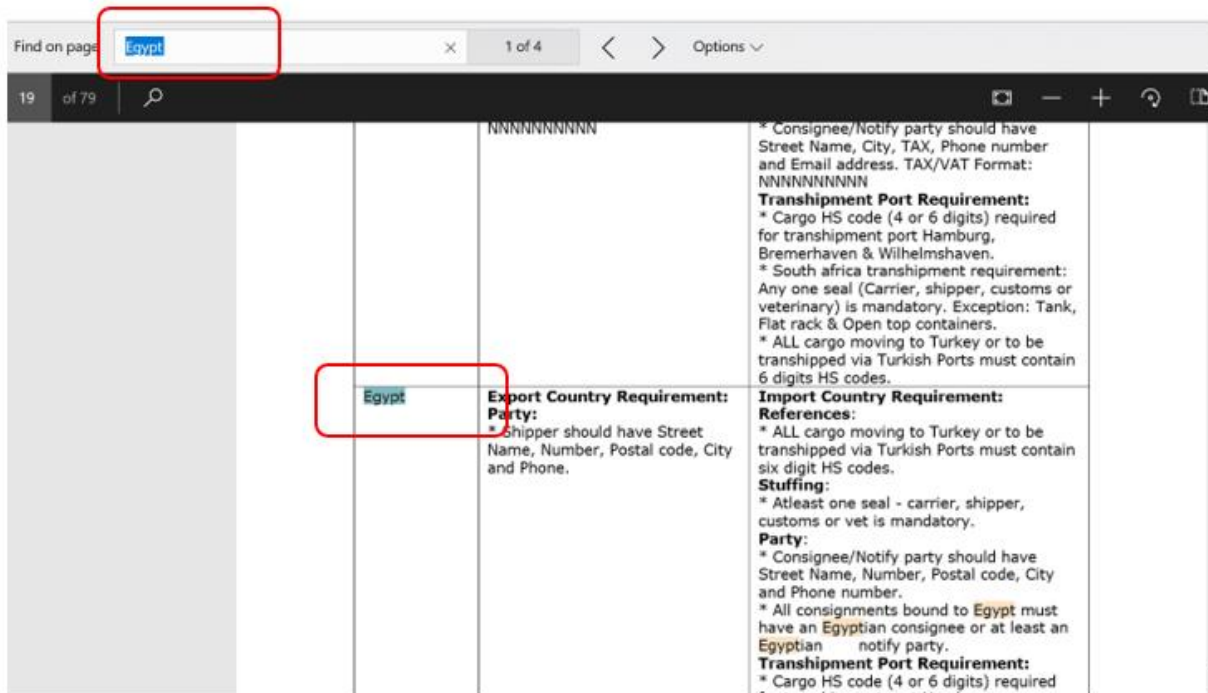
