Update on Sea Cargo Manifest & Transhipment Regulation for India

고객 제위,

좀 더 쉽게 비즈니스를 할 수 있도록, 간접세 및 세관 중앙위원회(Central Board of Indirect Taxes and Customs)에서는 인도에서 입출항 및 지나가는 모든 선박에 대한 해상운송 세관 신고 규정을 몇 가지 변경하였습니다.

이 규정이 시행되는 일자는 선적 서류 제출 기준으로 2020 년 2 월 16 일이 었습니다. 그러나 최근 인도세관의 공지 No.14/2020 에 따르면, 해당 규정의 강제 시행일이 2020 년 8 월 1 일로 변경되었습니다.

또한 세관에서는 **45 일의 유예기간**을 2020 년 5 월 15 일부터 2020 년 8 월 1 일까지를 통해서 모든 당사자가 자체적인 시스템 및 절차의 변경을 완료할 수 있도록 하였습니다. 위와 같은 상황에서, 머스크에서는 최종적으로 선적에 필요한 정보를 확인하여 다시 안내드리도록 하겠습니다.

G.S.R. (E). - In exercise of the powers conferred by section 157, rend with sections 30, 30A, 41, 41A, 53, 54, 56, sub-section (3) of section 98 and sub-section (2) of section 158 of the Customs Act, 1962 (32 of 1962), the Central Board of Indirect Taxee and Customs hereby makes the following regulations further to amend the Sea Cargo Manifest and Transhipment Regulations, 2018, namely: -

- Short title and commencement. (1) These regulations may be called the Sea Cargo Manifest and Transhipment (Amendment) Regulations, 2020.
 - (2) They shall come into force on the date of their publication in the Official Carette.
- In the Sea Cargo Manifest and Transhipment Regulations, 2018, in regulation 15:

 in sub-regulation (1), for the expression, "for the period of forty-five days from
 the date of commencement of these regulations", the expression, "from 15th
 May, 2020 till 1th August, 2027 whall be substituted.
 - in sub-regulation (2), for the words, figures and letters "16th February, 2020", the words, figures and letters "till 1" August, 2020" shall be substituted.

Update on Sea Cargo Manifest & Transhipment Regulation for India

Dear Customer,

As a step forward towards increasing ease of business, the Central Board of Indirect Taxes and Customs has made some changes in the regulation for filing Sea Cargo Manifest for all cargo arriving on the vessel calling India and departing on a vessel from India.

The go-live date for this implementation was **16th February 2020**; however as per the recent Customs Notification No.14/2020 it shall come into force with effect from **1st August 2020**.

Also, please note that Customs have proposed a transition period of **45 days** from **15th May till 1st August 2020** to enable all stakeholders to make necessary changes in their systems/processes.

Kindly refer the below circular received from customs communicating the change in implementation date.

- Short title and commencement. (1) These regulations may be called the Sea Cargo Manifest and Transhipment (Amendment) Regulations, 2020.
 - (2) They shall come into force on the date of their publication in the Official

 in sub-regulation (1), for the expression, "for the period of forty-five days from the date of commencement of these regulations", the expression, "from 15th May, 2020 till 1st August, 2020" shall be substituted;
 - in sub-regulation (2), for the words, figures and letters "16th February, 2020", the words, figures and letters "till 1" August, 2020" shall be substituted.
